#### **Puppet theatre in Apulia. Ethnography of a theatre that tried to shine with its own light**

##### **Abstract**

The theatre of animation has ancient roots in southern Italy; sporadic evidence of its existence dates back to 1600, becoming more frequent in 1700. More detailed information can be found from the early nineteenth century. Information about the names of the companies, the type of puppets, the shows we found in archival documents, in the permits that entrepreneurs forwarded to the authorities to give shows. Naples, Sicily, Palermo and Catania in primis are the most sought-after places by the companies. The presence of different types of animation shows is rooted and defined in these cities. The "pupo" a corpulent puppet, heavy, showy, often armed with sword, knife, stick was widely used in the theater cycles that were inspired by Charlemagne, Orlando and Rinaldo and in those that tell the exploits of bandits, camorristi, mafiosi loved by an audience that perceives them as popular heroes.

In this essay we deal with another region in which the theatre with puppets became established, Apulia, generating a strand with its own particular characteristics concerning the stories staged, the recurring characters, the techniques of animation and acting.

#### **My room at The Fountain: inclusion and exclusion strategies from within an enclave**

##### **Abstract**

This article is based on a reflection upon my ethnographic field-work conducted in the Northern Irish Protestant enclave of The Fountain, between 2003 and 2004 during my doctoral studies on martyrology in the Irish Republic tradition. The ethnographic field-work I conducted, the people round about me and the same topography of that research into a violent urban setting, made me understand that I was, too, the subject of anthropology. However, if on the one hand, this can make the ethnographer at home with the discipline of anthropology; on the other hand, security-related issues represented a continuous concern for both the ethnographer and the people dwelling in his research locus. After some fifteen years after my main field-work, the discussion will re-explore the challenges the ethnographer encountered while doing participant observation and, in particular, practicing anthropology in a violently divided society on ethno-religious lines.

##### **Abstract**

### **The traditions of St. John the Baptist from a distant past at the time of the Internet: the case of Lama dei Peligni**

#### **Abstract**

Lama dei Peligni is a town in the Abruzzo province of Chieti where up to about 60 years ago, the majority of the population practiced agriculture, followed by wage labor, craftsmanship and pastoralism. Now the population has been drastically reduced, there are no more shepherds and farmers and different traditions with secular roots have disappeared while others have been preserved and have been adapted to the new needs of the population. Among the traditions that have survived there are those regarding San Giovanni Battista. In this work we analyze and describe the traditions related to the cult of San Giovanni Battista, highlighting the transformations they have undergone, the process of refunctionalization to which they have been subjected and the new meanings acquired in the current situation following the diffusion on the web through a facebook site. In particular, the contemporary rituals that are practiced contribute to strengthen the collective identity, to escape momentarily from everyday life and serve as a tourist attraction. Through online distribution, on the other hand, we see communication without real faces and the formation of a new type of territorial and local identity.
